## **OLD BUSINESS**

- Manager reported that PBCWUD had issued a work order to relocate the backflow assembly following payment; contractor is ready to start on parking and speed bump project once that is completed.
- Matt Hadden and crew installed the new telescoping flagpoles on Tuesday, 3 November. Thank you, Matt!
- Manager reported on possible code violations at 1650 Southern Blvd. Code Enforcement is still
  researching the situation. Building is occupied by a renter who is storing personal vehicles at the
  residence. Further information will be forthcoming at December meeting.
- Council passed unanimously Ordinance 2020-2 dealing with vegetation height (changing from 18" max to 8" max). (Hadden/Eckerson, M/S/C)

- Representatives from Florida Power and Light (Mitrione and Bryan) presented ordinance for renewal of FPL Franchise with the Town. Payout rate remains at 6%, but the 10% holdback will be eliminated; Town will receive 100% of franchise payments. Public hearing to be held on Dec. 2 at the Council Meeting prior to 2<sup>nd</sup> reading and vote. Council unanimously approved ordinance on first reading. Eckerson/Hadden, M/S/C)
- Alberto Alvarez presented application for zoning variance in order to park his semi-truck/trailer at his residence at 2003 Summit. Manager will advertise a public hearing to be held on December 2, 2020 in the PBPost and alert residents within 500' of same.
- Manager announced election qualifying dates (Nov. 24-Dec. 8) and distributed documents to those up for election (A. McLane, R. McLane, G. Sullivan, M. Hadden).
